Financial Statements for year ending Jun 30, 2018 were reviewed and approved. Signed copies are provided as part of the minutes. Directors did not receive any remuneration during the year.

Activities for the fiscal year ending June 30, 2018 were reviewed:

- Altitude Project Community Support Foundation became a registered non-profit society in BC as of August 9, 2017
- Altitude Project Community Support Foundation applied for and achieved registered charity status in Canada as of April 23, 2018
- Fund raising goal for the 2018 school year was \$30,000 and \$31,747 was achieved
- Disbursements based on approved school budgets were made to the schools in the following villages:
  - o Saldang \$5,357
  - o Karang \$12,500
  - Komas \$8,000
  - o Ku \$1,500
  - o Solar lights \$3,679 special infrastructure project for villagers in Saldang, Karang and Komas
- Total disbursements \$31,037
- Two directors visited the Upper Dolpo schools in October 2017 to verify activities
- David Swain, President, will visit Nepal in December 2018 to meet with School Coordinators in Kathmandu
- Next trip planned to Upper Dolpo to visit schools is for September 2019
- Fund raising goal for the 2019 school year is \$40,000, as we anticipate needing to provide a higher degree of support to the school at Karang.

All three directors agreed to continue in their current positions for the next fiscal year. Meeting adjourned at 11:00 AM
